4. FIRST AID MEASURES

Remove the victim from the area of exposure. Wash off remaining material with plenty of water. In the event of any complaints or symptoms, avoid further exposure. Immediately consult a doctor.

Inhalation: If dust or spray mists have been inhaled, move victim to fresh air and remove source of contamination if safe to do so. The patient should be kept under observation. Obtain medical attention after significant exposure.

Skin: Remove contaminated clothing and shoes. Gently wipe off excess chemical. Wash skin gently and thoroughly with water and non-abrasive soap. Obtain medical attention if irritation persists.

Eyes: Seek medical attention immediately. Flush eyes with clean water for at least 15 - 20 minutes. Lift eyelids to facilitate irrigation. If present, remove contact lenses after 5 minutes and continue rinsing.

Ingestion: Do not give anything by mouth to an unconscious person. If the person is alert, rinse mouth thoroughly with water. Obtain medical attention.

Anticipated acute effects: May be harmful in contact with skin. Causes mild skin irritation. Causes serious eye damage.

Anticipated delayed effects: None known.

Most important symptoms/effects: Not known.

Advice to physician: No specific antidote is available. Treat symptomatically and supportively when required.

5. FIRE-FIGHTING MEASURES

Suitable Extinguishing Media: Extinguish fires with water spray, carbon dioxide, dry powder, or alcoholresistant foam.

Unsuitable Extinguishing Media: High volume water jet. **Specific hazards:** This product may emit toxic fumes when burned, including oxides of carbon, nitrogen and sulphur.

Special Fire Fighting Procedures: Remove spectators from surrounding area. Isolate the fire area and evacuate all personnel downwind of the fire. Fight fire from maximum distance and use unmanned hose holder or monitor nozzles. Keep upwind. Avoid inhaling hazardous vapours and fumes from burning materials. Remove container from fire area if possible and without risk. Do not use high volume water jet, due to contamination risk. Do not scatter the burning material. Water can be used to cool unaffected containers but must be contained for later disposal. Contain fire control agents for later disposal. Avoid pollution of waterways by run-off from the site.

Personal protective equipment: Wear NIOSH/MSHA approved self-contained breathing apparatus and full bunker gear.

6. ACCIDENTAL RELEASE MEASURES

Personal Precautions: Avoid contact with eyes. Do not breathe in spray mist or dust. Ventilate area of spill or leak, especially in contained areas.

Protective equipment: Refer to Section 8 for personal protective equipment to be worn during containment and clean-up of a spill involving this product.

Emergency procedures: Alert firefighting personnel, evacuate unprotected personnel and animals.

Environmental Precautions: Prevent spilled product from entering sewers, waterways or ground water. This product is classified to be very toxic to aquatic organisms and may cause long-term adverse effects in the aquatic environment. Any spillages or uncontrolled discharges into watercourses should be reported immediately to the police and the Department of Water/Environmental Affairs.

Methods and Materials for Containment: Contain spilled product.

Methods and Materials for Clean-up: Contain spilled product by picking up with an electrically protected vacuum cleaner or by wet-brushing and transfer to a container for disposal. Do not create a powder cloud by using a brush or compressed air. To decontaminate spill area, tools and equipment, wash with a suitable solution (i.e. organic solvent, detergent bleach or caustic). Add the solution to the drums already collected. Do not reuse spilled material. Dispose of in accordance with Section 13.

7. HANDLING AND STORAGE

Handling:

Precautions for safe handling: Harmful if swallowed. Avoid contact with eyes. Ensure adequate ventilation during handling and use. Do not handle broken containers without protective equipment. Immediately clean up spills that occur during handling. Keep containers tightly closed when not in use. In the case of contact with the product refer to First Aid Measures – Section 4.

General occupational hygiene: Practice good hygiene when using this material. Wash hands before eating, drinking, chewing gum, smoking, using the toilet or applying cosmetics. Worker should shower at the end of each workday. Launder all clothing before it is re-used.

Storage:

Conditions for safe storage: Keep under lock and key and out of reach of unauthorised persons, children and animals. Store in its original, labelled container, tightly closed, in an isolated, dry, cool and well- ventilated area. Avoid excessive heat. Avoid cross contamination with other pesticides and fertilisers.

It is essential to provide adequate ventilation. The measures appropriate for a particular worksite depend on how this material is used and on the extent of exposure. ENVIRONMENTAL EFFECTS:

Based on information for the active ingredient: Metsulfuron-methyl

<u>Plants:</u> In plants, undergoes complete degradation within a few days, by hydrolysis and conjugation. In addition to the hydroxymethyl analogue, other metabolites identified include methyl 2-(aminosulfonyl) benzoate and 2-(aminosulfonyl) benzoic acid. Rapidly metabolised within cereal plants.

Persistence and degradability: In soil, metsulfuronmethyl is broken down both by chemical hydrolysis and by microbial degradation. DT₅₀ (ave.) in a range of field soils is 52 days, with faster degradation in acidic soils.

Bio-accumulative Potential: Not determined.

Mobility in soil: Not determined.

Other adverse effects: Not determined.

13. DISPOSAL CONSIDERATIONS

Waste: Open dumping or burning of this pesticide is prohibited. Waste resulting from the use of this product cannot be reused or re-processed. Never pour untreated waste or surplus product into public sewers or where there is any danger of run-off or seepage into water systems. Do not contaminate rivers, dams or any other water sources with the product or used containers. Comply with local legislation applying to waste disposal. The product may be taken to a registered waste disposal site or incineration plant.
