PRECAUTIONS

- Avoid inhalation of the spray mist.
- Avoid contact with skin, eyes and clothing.
- Wash thoroughly with soap and water after application and accidental skin contact.
- Wash contaminated clothing after use.
- In case of contact with eyes, flush with plenty of water for at least 15 minutes; whilst eyelid(s) are open and if irritation persists obtain medical attention.
- Do not eat, drink or smoke whilst mixing or applying the product or before washing hands and face or change of clothing.
- Prevent drift onto other crops, grazing, rivers, dams or areas not under treatment.
- Clean applicator after use and dispose of wash water where it will not contaminate food, grazing, rivers or dams.
- TRIPLE RINSE THE EMPTY CONTAINER AS FOLLOWS:

Plastic container:

Invert the empty container over the spray or mixing tank. Thereafter rinse the empty container three times in succession with one quarter of the container volume fresh water and decant the rinsate into the spray or mixing tank. Puncture the triple rinsed container and dispose of via an approved collector or recycler (www.croplife.co.za). Do not bury, burn or donate the container to any other parties that may use it as a container for food or beverages.

Foil or paper bag:

Shake all the pesticide formulation out of the bag into the spray or mixing tank. Turn the bag inside out. Hold the bag over the spray or mixing tank and rinse the bag with running water for thirty seconds. Shake the rinsate off into the tank. Repeat the rinsing twice. Cut the bag into pieces and dispose of via normal refuse disposal. Do not bury, burn or donate the bag to any other parties that may use it as a container for foodstuffs.

Prevent contamination of food, feeds, drinking water and eating utensils.

FIRST AID TREATMENT

<u>Inhalation</u>: Remove source of contamination or move person to fresh air. Keep person warm and at rest. Treat symptomatically and supportively as and when required.

<u>Ingestion</u>: Rinse mouth. Never give anything by mouth to an unconscious person. Get medical attention if symptoms occur.

<u>Skin contact</u>: Remove contaminated clothing. Wash thoroughly with soap and clean water. If a rash or any of the symptoms appear, get medical attention.

Eye contact: Immediately flush the contaminated eyes with gently flowing lukewarm water for 15 to 20 minutes, occasionally lifting the upper and lower lids. Obtain medical attention if irritation develops and persists.

DIRECTIONS FOR USE: Use only as directed.

Spray volume per hectare:

Determine the spray volume required per hectare, using the Tree-Row-Volume model. Consult the technical advisor of the **AMID-THIN® W** distributor.

Application Instructions:

- AMID-THIN® W is a plant growth regulator for use on apples as a post-bloom (2 to 6 days after full bloom) thinning agent.
- The product may increase fruit weight, but this is dependent on fruit set and the physiological condition of the trees.
- AMID-THIN® W must be absorbed by the plant to be effective.
- Optimum results will be achieved on vigorous, healthy trees when sprayed under good absorption conditions. High relative humidity and slow drying conditions, favour maximum absorption.
- Various factors affect fruit set: tree vigour, provisions for cross-pollination, weather conditions and bee activity.
- Other important considerations include the previous year's fruit set level and the current year's food reserve status, which is affected by crop load and foliage vigour in the preceding year.
- It is important that early summer varieties are sprayed no later than petal fall, since applications 2 to 3 weeks later, often give insufficient thinning and may result in the development of inferior pygmy fruit.

USE RESTRICTIONS

- Do not apply AMID-THIN® W through any type of irrigation system.
- Do not apply AMID-THIN® W directly to water, to areas where surface water is present.
- Do not contaminate water when disposing of equipment wash waters.
- Do not contaminate irrigation ditches or water used for irrigation or domestic purposes.
- Do not apply when weather conditions favour drift from the treated area.
- Do not use in a greenhouse.

Mixing Instructions:

- Fill the spray tank with the required amount of **clean** water and add **AMID-THIN® W** with the agitator running.
- To ensure thorough mixing of **AMID-THIN® W**, allow a few minutes of agitation after adding to the water, before beginning spray operations.
- Agitator should be kept running during application.

APPLICATION RATES

Crop	Dosage Rate g / 100 t water	Remarks
Apples Golden Delicious & Royal Gala	70 g	Apply as a full cover spray 2 to 6 days after full bloom. Early summer varieties must be sprayed no later than petal fall, since applications 2 to 3 weeks later may give insufficient thinning. Apply a water volume of 400 litres per hectare.
