4. FIRST AID MEASURES

Remove the victim from the area of exposure. Wash off remaining material with plenty of water. In the event of any complaints or symptoms, avoid further exposure and consult a doctor.

Inhalation: If vapours or mists have been inhaled, move victim to fresh air and remove source of contamination if safe to do so. The patient should be kept under observation. Obtain medical attention if symptoms persist.

Skin: Remove contaminated clothing, shoes and leather goods. Wash skin gently and thoroughly with cold water and non-abrasive soap. Obtain medical attention if irritation persists.

Eyes: Flush eyes with clean water for at least 15-20 minutes. Lift eyelids to facilitate irrigation. If present, remove contact lenses after 5 minutes and continue rinsing. **Seek medical attention immediately.**

Ingestion: Do not induce vomiting. Do not give anything by mouth to an unconscious person. Obtain medical attention if the patient feels unwell. Administer oxygen if breathing is difficult. If breathing has stopped, give artificial respiration.

Anticipated acute effects:

Causes mild skin irritation.

May cause an allergic skin reaction.

Causes serious eye damage.

Harmful if inhaled.

Anticipated delayed effects: None known.

Most important symptoms/effects: Irritant effects on skin and mucous membrane are the most common reactions. Large ingestions can cause nausea, vomiting, abdominal distress and diarrhoea.

Advice to physician: There is no specific antidote available. Treat symptomatically and supportively.

5. FIRE-FIGHTING MEASURES

Suitable Extinguishing Media: Extinguish fires with carbon dioxide, dry powder or alcohol-resistant foam. Water spray can be used for cooling of unaffected stock, but avoid water coming in contact with the product.

Unsuitable Extinguishing Media: Water.

Specific hazards: In case of fire and/or explosion do not breath fumes.

Special Fire Fighting Procedures: Remove spectators from surrounding area. Isolate the fire area and evacuate all personnel downwind of the fire. Fight fire from maximum distance and use unmanned hose holder or monitor nozzles. Keep upwind. Avoid inhaling hazardous vapours and fumes from burning materials. Remove container from fire area if possible and without risk. Do not use high volume water jet, due to contamination risk. Do not scatter the burning material. Water can be used to cool unaffected containers but must be contained for later

disposal. Contain fire control agents for later disposal. Avoid pollution of waterways by run-off from the site.

Personal protective equipment: Wear NIOSH/MSHA approved self-contained breathing apparatus and full bunker gear.

6. ACCIDENTAL RELEASE MEASURES

Personal Precautions: Avoid contact with eyes and skin. Ventilate area of spill or leak, especially in contained areas.

Protective equipment: Refer to Section 8 for personal protective equipment to be worn during containment and clean-up of a spill involving this product.

Emergency procedures: Alert firefighting personnel, evacuate unprotected personnel and animals.

Environmental Precautions: Prevent spilled product from entering sewers, waterways, or ground water. This product is classified to be very toxic to aquatic organisms with long-term adverse effects in the aquatic environment. Any spillages or uncontrolled discharges into water courses should be reported immediately to the police and the Department of Water/Environmental Affairs.

Methods and Materials for Containment: Contain spilled product by diking area with sand, earth or silica gel. Methods and Materials for Clean-up: Cover contained spill with an inert absorbent material such as sand, earth or other appropriate non-combustible material. Vacuum, scoop, or sweep up material and place the material into a clean, dry, sealable container. Label containers with the contents and dispose of according to local regulations. Do not place spilled material back in original container. Do not re-use spilled material. Collect washings and add to the drums already collected. Do not flush spilled material or washings into drains or waterways. To decontaminate the spill area, tools and equipment, wash with water and suitable detergent (i.e. organic solvent, detergent bleach or caustic). Add the solution to the drums already collected. Open burning or dumping of this material is prohibited. See section 13 for disposal considerations.

7. HANDLING AND STORAGE

Handling:

Precautions for safe handling: Avoid contact with eyes and skin. Ensure adequate ventilation during handling and use. Do not handle broken containers without protective equipment. Immediately clean up spills that occur during handling. Keep containers tightly closed when not in use. In the case of contact with the product refer to First Aid Measures – Section 4.

General occupational hygiene: Practice good hygiene when using this material. Wash hands before eating, drinking, chewing gum, smoking, using the toilet or applying cosmetics. Worker should shower at the end of each workday. Launder all clothing before it is re-used.

Storage:

<u>Plants:</u> In plants, one major metabolite, which was also observed in animal metabolism studies, and several minor metabolites, were found.

ENVIRONMENTAL EFFECTS:

Persistence and degradability:

S-metolachlor:

In aerobic soils, dissipates rapidly due to microbial activity, mainly by degradation to two major metabolites (oxanilic and sulfonic acids), the formation of non-extractable residues (3.5-44%) and its mineralisation to CO₂ (3-30%). Geomean DT₅₀ (lab, aerobic) 21.2 d (7-96 d, (198 soils); Geomean DT₅₀ (field) 30 d (6-49 d, 12 soil sites); DT₉₀ (field) 36-165 d (12 soils). In water-sediment systems, S-metolachlor dissipates with a DT₅₀ of 42-53 d in the whole system.

Benoxacor:

In soil, benoxacor is rapidly dissipated via the formation of non-extractable residues (67–79% after 103 d down to 54–57% after 365 d) and is mineralized by microbial activity (up to 48–49% after 365 d). Soil DT₅₀ (20 °C) c. 1–5 d. Mean K_{oc} 218 ml/g (42–340 ml/g), indicating medium mobility. In aquatic systems, benoxacor mainly dissipates via the formation of non-extractable residues in the sediment (64–77%) with a DT₅₀ of 2.4 d.

Bio-accumulative Potential: Not determined.

S-metolachlor:

Mobility in soil: Adsorption (15 soils, pH 3.4-8.0, o.c 0.2-19.8%), mean K_{Foc} 189 (61-369 l/kg,) K_{F} 6.4 (0.3-44.8 l/kg) (15 soils, pH 3.4-8.0, o.c. 0.2-19.8%).
