#### 4. FIRST AID MEASURES

Remove the victim from the area of exposure. Wash off remaining material with plenty of water. In the event of any complaints or symptoms, avoid further exposure. Get medical help if you feel unwell.

**Inhalation:** Remove person from contaminated area to fresh air and assist breathing as needed. Seek medical attention if irritation occurs.

**Skin:** Remove contaminated clothing and shoes. Gently wipe off excess chemical. Wash skin gently and thoroughly with water and non-abrasive soap. **Obtain medical attention if irritation or rash occurs.** 

**Eyes:** Flush eyes with clean water for at least 15-20 minutes. Lift eyelids to facilitate irrigation. If present, remove contact lenses after 5 minutes and continue rinsing. **Seek medical attention.** 

**Ingestion:** Seek medical attention or call a poison control centre for treatment advice. Do not induce vomiting unless instructed to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. If the person is alert, rinse mouth thoroughly with water.

**Anticipated acute effects**: Harmful if swallowed. Causes mild skin irritation.

**Anticipated delayed effects:** Causes damage to organs (blood, nervous system, heart) through prolonged or repeated exposure.

Most important symptoms/effects: None known.

**Advice to physician**: Treat symptomatically and supportively. No specific antidote known.

#### 5. FIRE-FIGHTING MEASURES

**Suitable Extinguishing Media:** Use carbon dioxide or dry chemical for small fires and water fog or foam for large fires.

**Unsuitable Extinguishing Media:** High volume water jet. Use a water jet only to cool heated containers

Specific hazards: None known.

Special fire-fighting procedures: Remove spectators from surrounding area. Isolate the fire area and evacuate all personnel downwind of the fire. Fight fire from maximum distance and use unmanned hose holder or monitor nozzles. Remain upwind of fire. Avoid inhaling hazardous vapours and fumes from burning materials. Remove container from fire area if possible and without risk. Do not use high volume water jet, due to contamination risk. Do not scatter the burning material. Water can be used to cool unaffected containers but must be contained for later disposal. Contain fire control agents for later disposal. Avoid pollution of waterways by run-off from the site.

**Personal protective equipment:** Wear NIOSH / MSHA approved self-contained breathing apparatus and full protective gear.

#### 6. ACCIDENTAL RELEASE MEASURES

**Personal precautions:** Avoid contact with eyes and skin. Do not breathe in spray mist or dusts. Ventilate area of spill or leak, especially in contained areas.

**Protective equipment:** Refer to Section 8 for personal protective equipment to be worn during containment and clean-up of a spill involving this product.

**Emergency procedures:** Alert firefighting personnel, evacuate unprotected personnel and animals.

**Environmental Precautions:** Prevent spilled product from entering sewers, waterways or ground water. This product is classified as very toxic to aquatic organisms and may cause long-term adverse effects in the aquatic environment. Methods and Materials for Clean-up: Contain spilled product by picking up with an electrically protected vacuum cleaner or by wet-brushing and transfer to a container for disposal. Do not create a powder cloud by using a brush or compressed air. Label containers with the contents and dispose of according to local regulations. Do not place spilled material back in original container. Do not re-use spilled material. To decontaminate the spill area, tools and equipment, wash with water and suitable detergent. Collect washings and add to the drums already collected. Do not flush spilled material or washings into drains or waterways. See section 13 for disposal considerations.

#### 7. HANDLING AND STORAGE

#### Handling:

**Precautions for safe handling:** Harmful if swallowed. Avoid contact with skin and eyes. Do not breathe dusts or spray mists. Ensure adequate ventilation during handling and use. Do not handle broken packages without protective equipment. Immediately clean up spills that occur during handling. Keep containers closed when not in use. In the case of contact with the product refer to First Aid Measures – Section 4.

### **Engineering Controls:**

It is essential to provide adequate ventilation. The measures appropriate for a particular worksite depend on how this material is used and on the extent of exposure. **Persistence and degradability:** DT50 17 days in tama silt loam soil. Indoxacarb is considered to be moderately persistent; aerobic DT50 3–23 d, anaerobic DT50 186 d.

Bio-accumulative Potential: Metabolism in rats after oral dosing was studied using both DPX-JW062 and DPX-MP062. Most of the dose was excreted within 96 hours. Extensive metabolism to numerous minor metabolites occurs. In urine, metabolites were cleaved products (indane or trifluoromethoxyphenyl ring products), whilst, in faeces, major metabolites retained both these moieties. Major metabolic reactions included hydroxylation of the indane ring, hydrolysis of the carboxymethyl group from the amino nitrogen, and opening of the oxadiazine ring, which gave rise to cleaved products.

**Mobility in soil:** Indoxacarb is considered to be immobile;
