4. FIRST AID MEASURES

Remove the victim from the area of exposure. Wash off remaining material with plenty of water. In the event of any complaints or symptoms, avoid further exposure.

Inhalation: Immediately remove source of contamination or move victim to fresh air. If breathing has stopped, qualified personnel should perform artificial respiration and administer oxygen. Avoid mouth-to-mouth resuscitation. Keep person warm and at rest. Seek medical attention if irritation occurs.

Skin: Remove contaminated clothing and shoes. Gently wipe off excess chemical. Wash skin gently and thoroughly with water and non-abrasive soap. **Obtain medical attention if irritation occurs.**

Eyes: Flush eyes with clean water for at least 15-20 minutes. Lift eyelids to facilitate irrigation. If present, remove contact lenses after 5 minutes and continue rinsing. **Seek medical attention.**

Ingestion: Seek medical attention or call a poison control centre for treatment advice. Do not induce vomiting unless instructed to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. If the person is alert, rinse mouth thoroughly with water.

5. FIRE-FIGHTING MEASURES

Suitable Extinguishing Media: Use carbon dioxide or dry chemical for small fires and water fog or foam for large fires.

Unsuitable Extinguishing Media: High volume water jet. Use a water jet only to cool heated containers.

Specific hazards: Product contains combustible organic components; dense black smoke will be produced upon combustion that contains hazardous products.

Special Fire Fighting Procedures: Remove spectators from surrounding area. Isolate the fire area and evacuate all personnel downwind of the fire. Fight fire from maximum distance and use unmanned hose holder or monitor nozzles. Keep upwind. inhaling hazardous vapours and fumes from burning materials. Remove container from fire area if possible and without risk. Do not use high volume water jet, due to contamination risk. Do not scatter the burning Water can be used to cool unaffected material. containers but must be contained for later disposal. Contain fire control agents for later disposal. Avoid pollution of waterways by run-off from the site.

Personal protective equipment: Wear NIOSH/MSHA approved self-contained breathing apparatus and full protective gear.

6. ACCIDENTAL RELEASE MEASURES

Personal Precautions: Avoid contact with eyes and skin. Do not breathe in spray mists or dusts. Ventilate area of spill or leak, especially in contained areas.

Protective equipment: Refer to Section 8 for personal protective equipment to be worn during containment and clean-up of a spill involving this product.

Emergency procedures: Alert firefighting personnel, evacuate unprotected personnel and animals.

Environmental Precautions: Prevent spilled product from entering sewers, waterways or ground water. This product is classified to be very toxic to aquatic organisms and may cause long-term adverse effects in the aquatic environment. Any spillages or uncontrolled discharges into watercourses should be reported

immediately to the police and the Department of Water/Environmental Affairs.

Methods and Materials for Containment: Control spill at source provided it is safe to do so without risk.

Methods and Materials for Clean-up: Contain spilled product by picking up with an electrically protected vacuum cleaner or by wet-brushing and transfer to a container for disposal. Do not create a powder cloud by using a brush or compressed air. Label containers with the contents and dispose of according to local regulations. Do not place spilled material back in original container. Do not re-use spilled material. Collect washings and add to the drums already collected. Do not flush spilled material or washings into drains or waterways. To decontaminate the spill area, tools and equipment, wash with water and suitable detergent. See section 13 for disposal considerations.

7. HANDLING AND STORAGE

Handling:

Precautions for safe handling: Avoid contact with eyes and skin. Ensure adequate ventilation during handling and use. Do not handle broken containers without protective equipment. Immediately clean up spills that occur during handling. Keep containers tightly closed when not in use. In the case of contact with the product refer to First Aid Measures – Section 4.

General occupational hygiene: Practice good hygiene when using this material. Wash hands before eating, drinking, chewing gum, smoking, using the toilet or applying cosmetics. Worker should shower at the end of each workday. Launder all clothing before it is re-used.

Storage:

Conditions for safe storage: Keep under lock and key and out of reach of unauthorised persons, children and animals. Store in its original labelled container tightly closed, in an isolated, dry, cool and well- ventilated area. Avoid excessive heat. Not to be stored next to foodstuffs, feed and water supplies. Avoid cross contamination with other pesticides and fertilisers.

Engineering Controls:

It is essential to provide adequate ventilation. The measures appropriate for a particular worksite depend on how this material is used and on the extent of exposure. Plants: Metabolism proceeds via oxidation at the pyrrole ring, followed by ring opening and the formation of pyrrolidine carboxylic acid. In general, fludioxonil is metabolised to more than 10-15 minor metabolites.

>1000 mg/kg

Persistence and degradability: Formation of bound residues is the major route for dissipation in soil. Field DT_{50} *c.* 14 days and *c.* 26-54 days after foliar and seed treatment use, respectively. Photolytic DT_{50} in water is 9-10 days (natural sunlight).

Bio-accumulative Potential: Log K_{ow} 4.12. Well absorbed from the gastrointestinal tract, rapidly distributed in the body and completely excreted. The major metabolic reaction is the oxidation of the pyrrole ring at the 2-position. All metabolites are excreted as conjugates, mainly glucuronides.

Mobility in soil: In leaching and adsorption/desorption experiments, the compound proved to be immobile in soil. **Other adverse effects:** Not determined.

13. DISPOSAL CONSIDERATIONS

Waste: Open dumping or burning of this pesticide is prohibited. Waste resulting from the use of this product cannot be reused or re-processed. Never pour untreated waste or surplus product into public sewers or where there is any danger of run-off or seepage into water systems. Do not contaminate rivers, dams or any other water sources with the product or used containers. Comply with local legislation applying to waste disposal. The product may be taken to a registered waste disposal site or incineration plant.

Container: Emptied containers retain dust and product residues. Do not re-use the empty container for any other purpose. Empty containers by inverting the empty container over the spray or mixing tank. Thereafter, rinse the container three times with a volume of water equal to

a quarter of that of the container. Puncture the triple rinsed container and dispose of via an approved collector or recycler (www.croplife.co.za). Do not bury, burn or donate the container to any other parties that may use it as a container for food or beverages. Observe all labelled safeguards until container is destroyed.
